1. Adoption of the 2023-2024 AGM Agenda

The Chairperson proposed the motion to adopt the agenda, which was unanimously approved without objection or abstention.

2. Adoption of the 2022-2023 AGM Meeting Minutes

The Chairperson proposed the motion to adopt the previous AGM minutes, which was unanimously approved without objection or abstention.

3. Election of the 11th PTA Standing Committee (SC) Members (Year 2024-2026)

The Treasurer presented and summarized the Audited Income & Expenditure Account. This report was similarly distributed to members via the intranet before the AGM and displayed on the notice board. The Treasurer reported a healthy financial status for the PTA in the 2023-2024 financial year.

7. Approval on the Annual Report 2023-2024 and the Financial Report 2023-2024

The Chairperson proposed the motion to approve both reports, which was unanimously

approved without objection or abstention.

throughout the 2023-2024 school year.

9. Appointment of 2024-2025 Honorary Auditor and Honorary Legal Advisor

The Chairperson proposed the reappointment of Ms. Pheona Chow as Honorary Legal

Advisor as well as Mr. Lewis Chou as Honorary Auditor for 2024-2025 academic year.

The motion was unanimously approved without objection or abstention.

This year's AGM was held in a hybrid format, with an online Zoom option complementing

the in-person meeting. Overall attendance exceeded 80 parents.
